ORDER NO. 53 OF 2011

The President is pleased to appoint the following officers of Indian Revenue Service (Income Tax) to the grade of Joint Commissioner of Income Tax (OSD) purely on *ad hoc* basis in the PB 3-Rs. 15,600-39,100 +7,600/- with immediate effect and until further orders.

2. The promotions are intended to be purely of *ad hoc* nature and subject to the following conditions:

- (iii) will not confer any right or equity in favour of the appointees.
