The application forms for the Diplomatic/Official Passports with photographs of prescribed size in white background and endorsement of your Head of Office and also original certificate of **Safe Custody** of blue Passport, & copy of **Identity Card** may kindly be sent to this office urgently through Special Messenger to apply for the Diplomatic/Official passports in Delhi. Expired original blue passport or Diplomatic/Official passport if held by any officer will also have to be enclosed with the application for new Diplomatic/Official passport.
4. Travel and DA entitlements for the journeys undertaken within India shall be borne by the respective CCITs/CCAs. Arrangements for International Travel are being made. DA for the International Attachment shall be drawn for the nominated officers from Government and shall be disbursed and credited in their Bank A/cs before their departure for USA.
