Now, Central Govt. subscribers also have an option to open Tier II accounts through eNPS. In addition, eNPS based Registration option (for Tier I and Tier II) has been introduced to Subscribers of Autonomous Bodies (CABs, SABs) and State Govt. Subscribers can open account on the basis of Aadhaar or KYC verification by Nodal Offices. Subsequent verification and authorization of request by Nodal Office is mandatory for opening Tier I and to open Tier II, active Tier I account is mandatory. 7	Error Rectification Module in NPS Contribution	 At the time of contribution processing, in case if any error is found in any record, instead of entire file getting rejected, only that record will be rejected and the other records without any error will be processed. The feature for respective Offices will be enabled in the CRA system based on request received by Nodal Offices across various sectors.
8	Funds allocation ratio for Govt sector subscribers	 The funds allocation ratio for Govt sector (CG & SG) for the default scheme has been revised for three PFMs in the ratio of SBI (31%), UTI (34%) and LIC (35%). Accordingly, footnote has been added in the Transaction Statement for CG & SG Subscribers indicating change in the PFM scheme ratio.
9	Bank account type of Nodal Office	 In addition to existing bank account types of Saving and Current account, additional account type of 'Government Account' has been created in CRA system. Accordingly, Bank account type needs to be picked up in ERM requests.
	Dual OTP authentication on eNPS	Dual OTP Authentication has been introduced in addition to eSign for the following things, Tier II Activation Tier II - Tax Saver Scheme (TTS) Activation
11	Registration by	Direct Corporates can now onboard new Subscribers (employees) through screen based Online PRAN Generation Module (OPGM) in addition to the existing mode of registration.
